#### 3. Purpose and legal basis of data collection

The man Objecta GmbH & Co. KG collects your data for the purpose of order processing or for the fulfilment of its contractual, pre-contractual and legal obligations.

The collection and processing of data is necessary to be able to execute your order. The legality of the processing is based - in the course of the contract initiation and fulfilment - on article 6 paragraph 1, lit. b) GDPR and in the course of the processing due to legal requirements on article 6 paragraph 1, lit. c) GDPR.

In order to inform you about upcoming events, special offers or to send Christmas greetings, we use your address data to send you information by post. If we collect your e-mail address for the purpose of processing your order, we also take the liberty of sending you this information electronically. This procedure is based on our legitimate interest in direct advertising and thus on Art. 6, Para. 1, lit. f) GDPR, in conjunction with Recital 47.

You have the right to object to this use of your address data at any time. Please address your objection to the responsible body or simply reply directly to the information e-mail. Of course we will not charge you any costs for this. We base this processing on the law on unfair competition (UWG) § 7.

#### 4. Recipient

As far as necessary for the execution of the contract or required by law, these data will be passed on to authorities and to the service providers or comparable third parties necessary for the execution of the contract.

#### 4.1 Service provider

We are supported in the IT area by appropriate service providers. In this context we also use the possibility of (remote) maintenance. Here it cannot be completely prevented that master data of you are seen



by the executing technicians. However, the technicians have been obliged to maintain strict confidentiality in the course of a contract for order processing in accordance with Art. 28 GDPR. Among the service providers used are:

## 4.2 Subcontractors

If necessary, subcontractors (third parties) are used and commissioned to fulfill the contract. Necessary data will be transmitted to the subcontractors for the fulfillment of the contract.

## 4.3 Logistics partners

We provide our logistics partners with the delivery address and contact details for the shipping of the ordered products to coordinate the delivery date.

## 4.4 Support by external agencies

In addition, the possible recipients include our tax advisor, the tax office and, in the event of a legal dispute, our law firm, as well as the competent courts

Under no circumstances do we transfer your personal data to a third country or any other international organization outside the EU or EEA.

#### 5. Duration of storage

The data will be deleted as soon as they are no longer required for the purpose of their processing. The storage periods of six and ten years under tax law (§ 147 AO) and commercial law (§ 257 HGB) must be observed.

#### 6. Your rights

You have the right to request information about the data stored about you at the above address (Art. 15 GDPR) and, if the data is incorrect, to request that it be corrected (Art. 16 DS-GVO) or, if the data is stored illegally, that it be deleted (Art. 17 GDPR). You also have the right to restrict processing (Art. 18 GDPR) and to demand data transferability (Art. 20 GDPR).

You also have the opportunity to address a complaint to the data protection officer mentioned above or to a data protection supervisory authority. The data protection supervisory authority responsible for us is:
